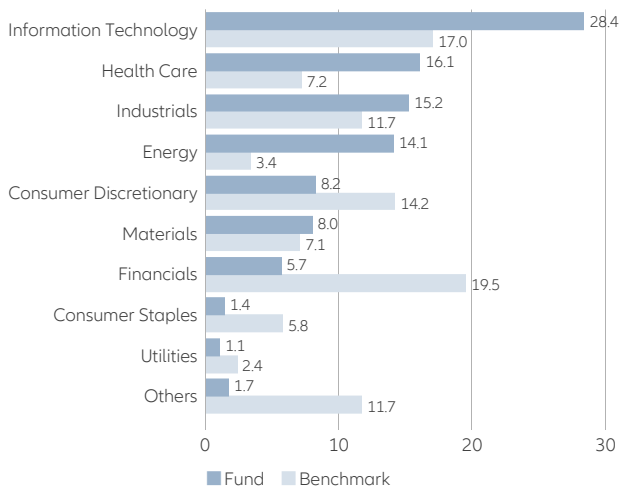

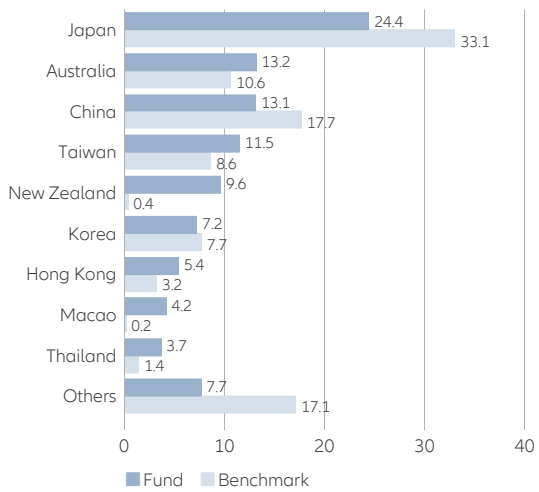
### Sector Breakdown (%)



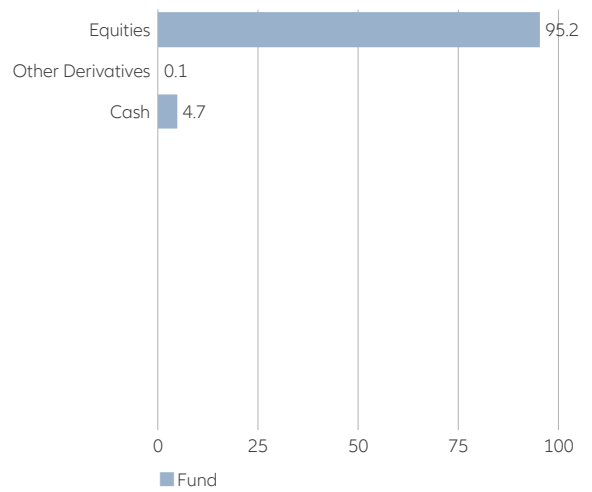
